
#### **Executive Summary**

In the second quarter of 2022 US private equity funds invested approximately \$157 billion over 1,425 deals. Companies in the **Information Technology** sector received \$43.5 billion in investment, with an average investment of \$851 million. Companies in the **Business Products and Services (B2B)** sector received approximately \$46 billion in investment. The average deal in this sector was \$446 million. The Information Technology and Business Products and Services (B2B) sectors made up more than half of all deals this quarter. Investment in companies in the **Health Care** sector reached \$17 billion in Q2, with an average deal of \$162 million. And investment in the **Consumer Products and Services (B2C)** sector was \$22 billion, with an average investment of \$372 million. Investment in the remaining sectors went as follows, businesses in the **Financial Services** and **Energy** sectors secured \$13.5 billion and \$7.9 billion, respectively. The average financial services deal was \$789 million and the average deal for an energy company was \$262 million. Companies in the **Materials and Resources** sector received \$6 billion in investment last quarter, with an average deal of almost \$189 million.


One of the largest deals of the second quarter was the buyout of Anaplan, a company that offers cloud-based business planning and performance management services, for \$10.7 billion.
