
Executive Summary

In the fourth quarter of 2022 US private equity funds invested approximately \$163 billion over 1,508 deals. Companies in the **Business Products and Services (B2B)** sector received approximately \$62 billion in investment. The average deal in this sector was \$100 million. Companies in the **Information Technology** sector received \$40.1 billion in investment, with an average investment of \$153 million. The Information Technology and Business Products and Services (B2B) sectors made up more than half of all deals this quarter. Investment in companies in the **Health Care** sector reached \$16.5 billion in Q4, with an average deal of \$80 million. And investment in the **Consumer Products and Services (B2C)** sector was \$15.7 billion, with an average investment of \$73 million. Investment in the remaining sectors went as follows, businesses in the **Financial Services** and **Energy** sectors secured \$14.3 billion and \$11.7 billion, respectively. The average financial services deal was \$108 million and the average deal for an energy company was \$265 million. Companies in the **Materials and Resources** sector received \$2.2 billion in investment last quarter, with an average deal of \$66 million.


One of the largest deals of the fourth quarter was the buyout of the social media platform Twitter by Elon Musk, Brookfield Asset management, Sequoia Capital and others for \$44 billion.



2022 and 2021 Industry Investment




